

## SUMMARY ANNUAL REPORT

### FOR GETTYSBURG COLLEGE HEALTH AND WELFARE PLAN

This is a summary of the annual report of the Gettysburg College Health and Welfare Plan, EIN 23-1352641, Plan No. 510, a welfare benefit plan, for period January 1, 2007 through December 31, 2007. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Gettysburg College has committed itself to pay certain healthcare spending account claims incurred under the terms of the plan.

#### Insurance Information

The plan has contracts with Delta Dental of Pennsylvania, Standard Insurance Company and Highmark Blue Shield to pay health, vision, prescription drug, dental, life, long-term disability, and accidental death & dismemberment claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2007 were \$5,708,027.

Because these contracts include so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending December 31, 2007, the premiums paid under such "experience-rated" contracts were \$5,344,396 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$5,453,353.

You have the right to receive a copy of the full annual report, or any part thereof, on request. The items listed below are included in that report:

1. insurance information, including sales commissions paid by insurance carriers.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan (Gettysburg College, 300 North Washington Street, Gettysburg, PA 17325) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
