Biographical Note

John D. Rentz was born on August 30, 1845, in Berks County, Pennsylvania, to John Rentz (-1880) and Catherina Degler (1821-1893). He had two younger sisters, born in 1847 and 1849. His youngest sister died in 1860.

On October 5, 1861, John D. Rentz enlisted as a private in Co. G, 96th Pennsylvania Infantry, at age seventeen. Rentz served with the regiment until he was mustered out on July 17, 1865, as a Corporal.

In 1867, Rentz married Ellen Malinda Mengel (1848-1905). Their son, Irvin Clayton (alternately written as Calvin) Rentz was born November 6, 1867. The family lived in Shartlesville, Berks County, Pennsylvania, where Rentz worked as a carpenter. Ellen Malinda Mengel Rentz died on March 17, 1905. By 1910, John D. Rentz was living with his son at 224 Bloomingdale Avenue, in Radnor Township, Pennsylvania. He died on November 17, 1906, and was interred at the Freidens Union Cemetery in Strausstown, Berks County, Pennsylvania.

Historical Note

The 96th Pennsylvania Infantry was originally attached to Slocum's Brigade, Franklin's Division, in the Army of the Potomac, before eventually being attached to the 2nd Brigade, 1st Division, of the 6th Army Corps. The regiment participated in a wide array of engagements with the Army of the Potomac, including the Battles of Antietam, Fredericksburg, Chancellorsville, Gettysburg,

Spotsylvania, Petersburg, and Cedar Creek. The regiment was mustered out of service on October 21, 1864.¹

Scope and Content Note

John D. Rentz's Civil War diary chronicles the time he spent with the 96th Pennsylvania Infantry between December 26, 1863, and September 6, 1864. The diary details a wide array of information pertaining to his life with the regiment and the progress of the Civil War.

Rentz's pension letter is very simple, merely asking for B. Penrose's assistance with securing a renewal of his pension.

The "Rebel letter" written by Margaret Jones to Joseph King is also simple, providing a few details about the rainy weather, the progress of the crops, and expressing Jones's desire to see her brother.

The 3-page manuscript, written for the Patriotic Order of the Sons of America, an organization once associated with the Know-Nothing Party, conveys a high level of concern about "foreigen competition" (pg. 1). The author is unknown, but the handwriting does resemble John D. Rentz's handwriting.
