

#### Provenance

This collection was given by Susan Perkins, widow of Roswell, via the Eisenhower Institute.

#### **Biographical Note**

Roswell B. Perkins held many titles throughout his life, working in both the government and in law. Born in Boston in 1926, he was a graduate of Harvard College and Harvard Law School. He joined the law firm Debevoise, Plimpton, and McLean in 1949, and remained in the firm until retiring in 2001. He was also president of Youth for Eisenhower in 1951 and 1952, before joining as the Assistant Secretary to the newly formed Department of Health, Education, and Welfare during the department's first years from 1953-1956. After his years as Assistant Secretary, he became a partner at this law firm in 1957 and Counselor to Governor Nelson Rockefeller from 1958-59. He was also president of the American Law Institute from 1980 to 1993, and continued to have many other titles throughout his life, working on committees and many other endeavors. He passed away in 2019.

## Scope and Content Note

This collection contains a variety of research, records, and correspondence related to Perkins' work throughout his lifetime. Folders were organized according to their original organization where possible. There are many documents from HEW during his time as Assistant Secretary, detailing subjects such as the approval of the Salk Polio Vaccine, statements to Congress over water safety, departure letters to and from other members of the department, and his advisory work to the department after his stint as assistant secretary (such as the 1974 Medicare review by an advisory committee he chaired). There is a fair amount of research from outside parties into the first Secretary of HEW, Oveta Culp Hobby, whom Perkins worked with and gave interviews and information on for these research projects. There is also a large amount of Eisenhower memorabilia from throughout his life, from his work at Youth for Eisenhower to the communications between him and the Eisenhower Memorial Committee as an advisor.

It also contains books kept by Perkins with inscriptions or other importance to the collection.
