

# CW/VFM-80: Transcript and letters about the Documents of William H. Rupp

<u>Diary of William H. Rupp of the 26<sup>th</sup> Pennsylvania, Co. A; and of the 87<sup>th</sup> Pennsylvania, Co. F:</u>

The 26<sup>th</sup> Pennsylvania militia was organized on June 22, 1863 specifically for Lee's assault on Pennsylvania, and therefore only did duty in the department of the Susquehanna near Gettysburg in early July of 1863. They were mustered out on July 31, 1863.

He also served with the 87<sup>th</sup> PA regiment, which was organized in September of 1861. This regiment saw action at the battles of Winchester (6/13-15/1863), Spotsylvania (5/8-21/1864), Cold Harbor (6/1-12/1864), Petersburg (4/2/1865), and were present for the surrender at Appomattox Courthouse (4/9/1865).

William Rupp mentions very little about the battle of Gettysburg. He didn't participate in the fighting at all and, as his diary refers to his anxiety over waiting for news over the proceedings of the battle, he wasn't one of the ones that were captured in the initial skirmishing.

#### Research Paper by Kathryn R. Funk (4/27/1989):

This document directly deals with the influence of the 26<sup>th</sup> Pennsylvania Militia as the first Union troops to oppose the Confederate advance into Pennsylvania. However, they missed the battle of Gettysburg and never did any hand-to-hand combat with enemy. Only the men taken prisoner during the initial skirmish witnessed the fighting that occurred at Gettysburg.
